- · Circumstances are beyond your control
- Circumstances that made it impractical for you to complete your placement e.g. medical, family/personal circumstances. Accidental
  injury or illness affecting ability to practice.

### **Application period**

Students may apply anytime from the Early Online Withdraw Deadline until the Census Date for the relevant unit.

### Supporting documents

Your application needs to include independent documentation to support your special circumstances. For example:

- a letter from your treating professional (medical certificate will not be accepted)
- · death certificate
- · police statement

## Notification to applicants and appeals process

A panel of University representatives (Professional Practice Leader/Course Chair/Unit Convener) will consider your application and notify you within 10 business days from when the application was received. If you are not satisfied with the decision, you will need to follow the University Appeals process within 20 working days from receiving your outcome.
