Course Delivery Information: This course is designed to be taken as either On Campus or Online (Online Self-Paced). Students on student visas are required by the conditions of their visa to attend the course in person.

Unit sequence: Units must be studied in a strict sequence, outlined below. Please note, you must enrol in both ECE6012 and ECE6013 in the same block. Placement: Students are required to complete 60 days of supervised placement in an early childhood education setting. All students are offered support from the Partnership office to source their placement. Up to 50% of placement can be undertaken in the workplace. Various Unit Delivery Modes:
