## **VU Future Leaders Scholarship (International)**

**The VU Future Leaders Scholarship (International) supports new international students who plan to commence their undergraduate or postgraduate (coursework) studies in 2022.**

**How to apply:** Students will be required to confirm that they wish to be considered for the scholarship at the time they submit their application for admission into an eligible VU qualification. Scholarship eligibility can only be assessed after the applicant has met the course entry requirements.

**Scholarship value (2022 commencement):** 20% off the course tuition fee for the full duration of the course.

**Eligibility (2022 commencement):** All new students commencing an undergraduate or postgraduate (coursework) course (including ELICOS EAP packages) with VU Sydney in 2022 are eligible (please refer to terms and conditions below).

### **Terms & Conditions:**

- Students must pay the required tuition fee deposit to accept their offer. The remaining balance is due before the course start date.
- Students who have received a scholarship or sponsorship from another organisation are not eligible for this scholarship.
- Students cannot access **The VU Future Leaders Scholarship (International)** if already in receipt of the High Achiever Scholarship.
- Current VU students changing from one course to another with Advanced Standing (credits) are not eligible for this scholarship.
- Students with approval to reduce their study load are eligible to receive a reduced scholarship, based on the number of units taken (pro-rata).
- **The VU Future Leaders Scholarship (International)** is not refundable, convertible to cash, or transferable to another individual, commencing study period, or course.
- **The VU Future Leaders Scholarship (International)** is awarded at the discretion of the University.
- The student will continue to remain eligible to receive the **VU Future Leaders Scholarship (International)**, and the extension of the scholarship providing the student pays all tuition and additional fees/costs in full by the census date each study period and meets the conditions of their student visa.
- Victoria University may make changes to these terms and conditions without notice.

- The University's decision concerning the assessment of eligibility for the Scholarship is final, and there is no right of appeal should the student be unsuccessful in securing the scholarship, or has the scholarship withdrawn.
